### **OVERVIEW OF PROCESS** TIME PROVEN WEAPONS ACCOUNTABILITY PROCESS

- **Submit pre-arrival report** to notify Port Authority of weapons and ammunition on board.
- Vessel Master ensures weapons and ammunition are secured prior to entering territorial waters.
- Weapons, ammunition and security personnel remain on-board throughout the port visit.
- Weapons and ammunition remain secured until re-entry into international waters.

# **INDIA MODEL**

The "India model" of managing armed security teams is an example of excellent control and management which benefits the shipping clients, resulting in continued and growing maritime imports, at the same time ensuring the security of India.

- 1. Vessel Master submits a pre-arrival report which includes the normal vessel cargo, immigration and vessel certification data as well as a detailed list of all weapons and ammunition on board.
  - a. All weapon serial numbers are submitted
  - b. Copies of weapons licenses showing Trident Group as the owners of the weapons are submitted.
  - c. An exact count of ammunition onboard is submitted.







## **INDIA MODEL**

#### **Continued:**

2. Upon entry into territorial waters, all weapons and ammunition are locked in a secure container which is under the control of the ships Master.

3. Host nation Customs personnel board the vessel with the pilot and verify all serial numbers and ammunition counts. Weapons and ammunition container is then sealed with Customs seals which may not be broken or removed.

4. Vessel enters port. While in port, all weapons, ammunition and security personnel remain onboard the vessel.

# **INDIA MODEL**

#### **Continued:**

5. Following cargo offload/reload of vessel, and prior to vessel dropping lines to get underway; Customs personnel board the vessel and verify that weapons and ammunition storage container seals are intact which confirms that the contents have not been touched while in port.

6. Customs notifies Port Authority that inventory is intact and untouched.



7. Port Authority provides vessel with port departure clearance.

This system has been used for over twelve years (to date) without a single TGA violation or incident involving weapons and ammunition.
